REVISED NOTICE TO CONTRACTORS

Proposals shall be submitted under sealed cover plainly marked as a proposal, and identifying the project to which the proposal relates and the date of the bid opening therefore. Proposals which are not properly marked will be rejected. Sealed proposals will be received at the office of Napa County Public Works, 1195 Third Street, Suite 101, Napa, California, until **3:30 P.M. on May 28, 2019** (no bids will be accepted after 3:30 P.M.) after which they will be publicly opened and read for the construction in accordance with the Plans and Special Provisions thereto, to which special reference is made as follows:

**American Canyon Landfill Standby Generator
Project No. 19810**

Engineer's Estimate: \$ 130,000

Bids are required for the entire work called for by the Plans and Specifications, and neither partial nor contingent bids will be considered.

Bid results of the three apparent low bidders with their subcontractors list will be on the County's website <https://www.countyofnapa.org/Bids.aspx> one day after the bids are publicly opened and read.

The Plans and Specifications may be seen at the office of Napa County Public Works, 1195 Third Street, Suite 101, Napa California. Plans, Special Provisions (excluding State Standard Specifications and other documents included by reference), Proposal Forms and Contract Forms may be obtained at said office by prospective bidders by those contractors licensed by the State of California for the type of work involved, for a fee of ten dollars (\$10) per set, which fee is not refundable.

In accordance with the provisions of Section 1774 of the Labor Code of California, the prevailing wage rates for classifications of Labor to be employed in the work have been determined by the Board of Supervisors of Napa County (as utilized by the Authority) and are included in the Special Provisions referred to above.

No bid will be considered unless it is made on a blank form furnished by the Authority Executive Director and is made in accordance with the provisions of the proposal requirements and conditions set forth under Section 2 of the Standard Specifications of the State California, Department of Transportation, dated 2006, except as modified in the above referred to Special Provisions.

Each bidder must possess a California Class C-10 Contractors License.

Contractors bidding the project may attend an optional pre-bid site visit scheduled for May 14, 2019 at 10:00 A.M. The meeting point is the Maintenance Shop Yard, American Canyon Landfill, located at the western terminus of Eucalyptus Drive, American Canyon, CA 94503. (Note: The site does not have a physical address.)
