

**NAPA COUNTY AGREEMENT NO. 7682
AMENDMENT NO. 2**

THIS AMENDMENT NO. 2 TO AGREEMENT NO. 7682 is made and entered into as of this 25th day of August, 2015, by and between NAPA COUNTY, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and AMERICAN MEDICAL RESPONSE WEST, a California corporation doing business as American Medical Response, hereinafter referred to as "CONTRACTOR" or "AMR."

RECITALS

WHEREAS, on or about October 12, 2011, COUNTY and CONTRACTOR entered into Napa County Agreement No. 7682, (hereinafter referred to as the "Agreement") for the CONTRACTOR to provide emergency medical response services within the County; and

WHEREAS, on or about December 13, 2013, the parties amended the Agreement to clarify certain terms and amend the Medical Cache Trailer responsibilities; and

WHEREAS, the parties wish to amend the Agreement to replace the provision that required CONTRACTOR to acquire and equip a Mobile Simulation Center.

TERMS

NOW, THEREFORE, Napa County Agreement No. 7682 is hereby amended as follows:

1. Section 4.4.3 is replaced in its entirety and now reads in full as follows:

4.4.3 PulsePoint – Crowdsourced CPR and AED Smartphone Application

Contractor shall fund the one-time fixed implementation costs of the PulsePoint Respond and AED smartphone applications. Contractor will provide full funding costs, not to exceed \$18,000 to the City of Napa within three (3) months of contract amendment authorizing this provision.

2. Except as provided above, the terms and conditions of the Agreement shall remain in full force and effect as originally approved and last amended.




