To file a claim for these funds you may contact the Napa Sheriff's Office Civil Division at 1535 Airport Blvd, Napa CA 94559 or by calling (707)253-4325. A party of interest may file a claim with the Sheriff Civil Division, which must include the claimant's name, address, amount of claim, the grounds on which the claim is founded, and any other information that may be required on a Sheriff Civil claim application. The claim shall be filed before the date the unclaimed money becomes the property of the local agency as provided under Section 50051 GC. **Your claim must be made within forty-five days of this publication.** Failure to file your claim will result in those funds being transferred to a government account and you will no longer have a claim to this money.
