Applicants sought for the Napa County Commission on Aging

NAPA - The County Executive Officer announces six (6) openings on the **Napa County Commission on Aging** representing the following categories:

- One (1) District 2 representative (2-year terms)
- One (1) District 3 representative (2-year terms)
- One (1) District 4 representative (2-year terms)
- One (1) District 5 representative (2-year terms)
- One (1) Organization Concerned with Older Adults representatives, term ending 9/30/24
- One (1) Organization Concerned with Older Adults representatives, term ending 9/30/23

This recruitment will remain open until vacancies are filled.

Commission Purpose: To serve as advocates by increasing awareness for issues impacting older adults and influencing public policy with the Napa County Board of Supervisors. Among the many issues on their agenda are aging in place, transportation, and healthy aging initiatives. The Napa County Commission on Aging consists of 15 members - one member from each of the five Supervisorial Districts and ten additional members-at-large.

Meetings take place on the fourth Monday of every month at the County Administration Building in Napa and other County-wide venues. These meetings provide an opportunity to hear updates from the Board of Supervisors and expert speakers from local and statewide agencies on topics related to older adults in Napa County.

Qualifications: Individuals who are interested in trends related to aging and working with the Board of Supervisors. It is desirable that all appointees are over the age of 55, but a person of a younger age will not be excluded. **PLEASE NOTE:** Individuals applying must include a letter of recommendation with the application. The letter must be from either an "Organizations Concerned with Older Adults," or "an individual who is familiar with the applicant's experience in advocating for older adults."
