UNDERSTANDING YOUR BILL

- 1 ACCOUNT INFORMATION.** View your account information, including account number, service address, service period (billing cycle), and billing date.
- 2 METER READING.** View the readings for previous and current meter readings, and usage (consumption). Readings and usage are listed in thousand gallons. For the meter pictured, usage is 11,000 gallons for the billing cycle.
- 3 CALCULATIONS OF CURRENT CHARGES.** View your Beginning Balance, typically from the prior billing cycle, the current sewer and water fixed and usage charges, any payments made to the account since the prior billing period, and Total Current Charges.
- 4 SUMMARY OF CHARGES.** View your previous balance, payments received, billing adjustments, and current charges due.
- 5 CUSTOMER MESSAGES.** This section is reserved for special District-wide messages about your bills that can include information about online payments, rebate programs if available, upcoming meetings, or water/sewer system advisories. Billing messages related to water and wastewater charges included in the bill may be printed in this section in lieu of separate mailings.
- 6 PAYMENT COUPON.** This section contains remittance information and should be returned with your payment to the address listed.
