## UNINCORPORATED NAPA COUNTY HIGH EFFICIENCY TOILET REBATE APPLICATION FORM 2018

**NAPA COUNTY (COUNTY)** is offering a rebate to residents and business located in the unincorporated County, for the purchase of High Efficiency Toilets (HETs) to increase water conservation. HETs are 1.28 gallons per flush or less and must have the **U.S EPA WaterSense®** label. Residential and business property owners in the unincorporated County, that do not pay a water bill to the City of American Canyon, City of Napa, Town of Yountville, City of St. Helena or City of Calistoga, may receive a rebate for approved expenses up to \$100 per toilet with a two toilet maximum per household/business. Funding for this rebate program is provided by Napa County and the State of California water bond measure, Proposition 84, administered by the California Department of Water Resources, and is subject to funding availability.

### REQUIREMENTS:

- **Before you purchase a toilet, please email [deborah.elliott@countyofnapa.org](mailto:deborah.elliott@countyofnapa.org) or call 707-259-5969 to verify that you are eligible for the rebate and funds are available for the program.**
- Application and all documentation must be received by Napa County by March 2, 2019
- Applicant must be a resident or business in unincorporated Napa County and must not pay a water bill to the City of American Canyon, City of Napa, Town of Yountville, City of St. Helena or City of Calistoga.
- Toilets purchased before July 1, 2017 or after December 31, 2018 are not eligible.
- HET(s) must replace toilet(s) older than 1993 or use 3.5 gallons per flush or greater.
- Two rebates maximum per household or business for HETs that are *U.S EPA WaterSense®* labeled.
- Renters must receive written consent from the property owner to participate in this program.
- Applicant may receive a rebate for approved expenses up to \$100 per toilet replaced. Purchase of qualifying toilet tank and toilet bowl only. Applicant/contractor labor will not be rebated.
- County not responsible for rebates that are lost/delayed. Keep the original receipt & copy of the application.
- California State sales tax and shipping will not be reimbursed by the rebate.
- HET must be installed before submitting rebate application.
- If selected for inspection, applicant agrees to allow access to the premises in order to verify installation.
- Due to limited funding, this rebate may be withdrawn at any time without notice.
- County reserves the right to deny any applications that do not meet the Program Requirements herein.
- Application must be submitted within 60 days of purchase. Processed on a first come, first served basis.
- Rebate checks will be mailed in 6-8 weeks after the County receives all completed documentation.

2. I understand the rebate amount cannot exceed the purchase price of the product, nor can it include taxes or shipping costs. Napa County reserves the right to limit the number of products rebated.
3. I understand I cannot receive a rebate for the same product(s) from more than one agency.
